

Acknowledgment of Risks and Waiver of Liability Relating to COVID-19

As a condition of participating in the Amity Soccer Club (ASC) travel or Orange Soccer Association (OSA) in-house recreational program, I hereby agree as follows:

I acknowledge that the Centers for Disease Control (CDC) designates older adults as being at higher risk of getting very sick from the Coronavirus Disease 2019 (“COVID-19”). I also acknowledge that on or about March 11, 2020, COVID-19 was declared a pandemic by the World Health Organization. I have read and understand the CDC’s recommendations, including those found at the following webpage, <https://www.cdc.gov/coronavirus/2019-ncov/specific-groups/high-risk-complications.html>, and have voluntarily chosen to participate in the ASC OR OSA program despite warning and notice.

I acknowledge the ASC OR OSA players, coaches, managers, board members, opponents and spectators may come into contact with multiple individuals and might become exposed to COVID-19. I also acknowledge although the ASC OR OSA takes precautions to reduce the likelihood of transmission of COVID-19 by its program protocols followed the ASC OR OSA cannot guarantee I will not become infected with COVID-19.

I knowingly acknowledge by participating in the ASC OR OSA program I am exposing myself to the risk of becoming infection with COVID-19, which may result in serious personal injury, illness, permanent disability, and death. I understand the risk of becoming exposed to or infected by COVID-19 may result from the actions, negligence and failures to act of myself and others, including, but not limited to, family members, other individuals with whom I come into contact, and the Released Parties (as defined below). I agree to assume all of the foregoing risks, and accept personal responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability or expense, of any kind or nature, that I may suffer arising out of or in connection with my becoming exposed to or infected by COVID-19 while participating in the ASC OR OSA program.

On my own behalf, and on behalf of my heirs, executors, administrators and next of kin, I hereby release, covenant not to sue, and forever discharge the Released Parties of and from all liabilities, claims, actions, damages, costs or expenses of any nature (“Claims”) arising out of or in any way connected with my becoming exposed to or infected by COVID-19 while participating in the ASC OR OSA program, and further agree to indemnify and hold each of the Released Parties harmless from and against any and all such Claims. I understand this release and indemnity includes any Claims based on the negligence, action or inaction of any of the Released Parties and covers bodily injury (including death) due to COVID-19, whether a COVID-19 infection occurs before, during or after participation in the ASC OR OSA program.

For the purposes hereof, the “Released Parties” are Amity Soccer Club aka Amity Soccer Association; Orange Soccer Association and the players & families, coaches, managers, opponents, spectators, board members, contractors, subcontractors, representatives, successors, assigns of each of the foregoing entities.
